MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: POLICY 019 – Discarding of Cigarettes/Cigars

1. All lit cigarettes/cigars will be properly extinguished and discarded in an enclosed receptacle.
2. Discarding lit cigarettes/cigars onto the ground or out of a vehicle window is an extreme fire hazard. It jeopardizes the safety of installation personnel and negatively impacts the environment. Violations of this policy pose a significant danger to the personnel and property and will not be tolerated.
3. The provisions of this policy pertain to all persons assigned to, in temporary duty status, or employed on Fort Huachuca, to include family members and guests. This policy is punitive in nature. Failure to abide by this policy is a violation of Article 92 and Article 134 of the Uniform Code of Military Justice and Arizona Revised Statutes (ARS) 28-7056 and 13-1603.
4. The proponent for this policy is the Directorate of Emergency Services, US Army Garrison, Fort Huachuca, Arizona 85613-7012.
5. This memorandum supersedes policy memorandum USAG, IMWE-HUA-ZA, 19 Jun 08, subject: POLICY 019 – Discarding of Cigarettes/Cigars.
